Event Cancelation:

Entry Draw:

In accordance with AKC Regulations, entries in this tracking test will be accepted up until the official closing date, even though the advertised limit has been reached. If the limit for entries is not reached in one test, and the limit is exceeded in the other test, the number of tracks will be exchanged (2 TDU per VST track) up to the limits set by AKC Tracking Regulations

(Chapter 1, Sec. 13a). Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the Test will be held at the home of the test secretary (13160 Waterville-Swanton Rd, Swanton OH 43558) Thursday April 18, 2024, at 6 p.m. The drawing is open to the public. This drawing, conducted by the test secretary, shall be completely at random from among the entries received, except that preference shall be given to those entries which have not earned a TDU or VST title.

When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above. The test secretary will notify all entries of the result of the drawing within 48 hours by telephone or email. Alternates have the option to accept or decline being placed on the alternate list. The assignment of dogs to the tracks is the responsibility of the judges.
