#### **Dogs who may not compete:**

No dog under the age of 6 months may compete in tracking events. No dog  
belonging wholly or in part to a judge, test chair, superintendent, official  
veterinarian, or any member of such a person's household may be entered  
in any Tracking Test at which such person officiates or is scheduled to  
officiate. Nor may they handle or act as agent for any dog entered at that  
test.

**Bitches in season:** Bitches in season may run in the test, but will be given  
the final track and must be restricted to their vehicle and potty areas as  
directed by the test chair.

#### **Errors on Entry:**

Owners are responsible for errors on entry forms, whoever may make such  
errors. No entry fee will be refunded in event of errors. No entry shall be  
made and no entry shall be accepted which specifies any conditions as to its  
acceptance. Entries cannot be accepted, cancelled, altered or substituted  
after the entries have closed. Mail both sides of the entry form, and fees, to

Phone or fax entries will not be accepted. Express mail entries must include  
the signature waiver. Illegible or incomplete entries will not be processed and  
will be returned to the exhibitor. **Receipt of entries will be acknowledged  
via email;** please provide a valid email address with entry. 100 percent of  
entry fees will be refunded (check destroyed) for any reason if written or  
email withdrawal request is received by the Test Secretary on or before the  
closing day and time. As required by the AKC Tracking Regulations, **a  
written certification form must accompany the TDU entry for any dog  
which has not previously passed an AKC TD or TDU test.**

#### **Event Cancellation:**

THE CLUB MAY CANCEL the event in case of extreme weather conditions.  
Extreme weather conditions, such as, but not limited to: snowstorms,  
hurricanes, lightning, extreme heat, heavy rains or other circumstances  
including but not limited to the condition of the facilities or grounds and/or  
ingress and egress from the grounds and must be considered for the health  
and safety of the dogs, exhibitors and spectators. The well-being of the dogs,  
exhibitors and spectators is of paramount importance and in the event it is  
necessary to cancel or stop the event before completion, no refund of entries  
will be made

### **Entry Draw:**

In accordance with AKC Regulations, entries in this tracking test will be accepted up until the official closing date, even though the advertised limit has been reached. If the limit for entries is not reached in one test, and the limit is exceeded in the other test, the number of tracks will be exchanged (2 TDU per VST track) up to the limits set by AKC Tracking Regulations

(Chapter 1, Sec. 13a). Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the Test will be held at the home of the test secretary (13160 Waterville-Swanton Rd, Swanton OH 43558) Thursday April 16, 2025, at 6 p.m. The drawing is open to the public. This drawing, conducted by the test secretary, shall be completely at random from among the entries received, except that preference shall be given to those entries which have not earned a TDU or VST title.

When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above. The test secretary will notify all entries of the result of the drawing within 48 hours by telephone or email. Alternates have the option to accept or decline being placed on the alternate list. Those who opt to decline shall have their entry fees returned upon written notification to the test secretary of their intention to withdraw from the alternate list. In the event an accepted entry cancels after the closing of entries, the test secretary shall contact alternates in the order of their placement on the alternate list. Upon such notification, alternates shall have the option to accept or decline the opportunity to participate in the test. No entry fee will be refunded except that of an alternate who does not participate in the test. Exception: In the event that an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry. In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the test secretary to determine if alternates are present, and to determine, by their position on the alternate list, which of the alternates will participate.

**WORKER DRAW** A worker draw will be used for this test in accordance AKC Regulations in Ch 1 Sec 17d. **One (1) VST track and one (1) TDU track** will be set aside for workers at this test. TKC worker draw coupon must accompany the entry.

### **TEST DAY DRAW FOR ORDER OF TRACKS:**

The draw will take place at the Test Headquarters with details to be provided on the Judging Program. The Test Secretary must be informed before the draw of any bitches in season and they will be assigned the last track. People cannot act as tracklayers for dogs if, within the last 10 days, they have boarded, laid a track for, or regularly trained the dogs whose tracks they are to lay. The Test Secretary must be notified prior to the drawing of tracks, and the judges will modify the draw to meet the requirements of the tracklayer. The order of the TDU tracks will be drawn on Sunday, May 4, 2025, at 7:15 a.m. The first TDU track will be run immediately following the draw. Drawing for VST tracks will be held after the TDU tracks have been judged, but not before 9:00 a.m. local time. Tracks will run following the draw. The assignment of dogs to the tracks is the responsibility of the judges.

### **WAIVER OF LIABILITY**

Toledo Kennel Club, the test secretary, test committee, Bowling Green State University, etc. assume no responsibility for loss, damage or injury sustained by spectators, exhibitors, and exhibitors' property and dogs and further assumes no responsibility for injury to children. Arbitration: TKC does not agree to arbitrate claims as set forth on the official AKC entry form for this event. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. If any exhibitor, their dogs and/or children create an unnecessary disturbance or repeatedly engages in unsafe or disruptive behavior, they may, at the discretion of the Test committee, be asked to leave the show site. In such case Club, the Test Committee, Bowling Green State University, and its agents, employees, etc., will assume no responsibility for any injury to people or dogs, no refund of fees paid will be made by the Toledo Kennel Club.

**The Toledo Kennel Club reserves the right to cancel the test due to extreme weather conditions. Dogs must be on lead at all times in any area of the tracking site. Owners must keep their dogs under control at all times and be respectful that this is a university setting where student life and education is paramount.**

Workers and participants will follow the AKC and State of Ohio, and/or Bowling Green State University directives as they pertain to Covid-19 at the time of the test.

## INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
